- The number of restricted share units issued by the Issuer to the Reporting Person was calculated based on \$37.08, which represents the mean of the highest and lowest sales prices per share of the Issuer's Class A common stock on the Nasdaq Exchange on the date of issuance.
- The award generally vests on March 9, 2025 at which point the units will be converted to an equal number of shares of the Company's Class A common stock.
